5.1 Treasurers Report

Summary provided by Jess Mountford. No issues – accounts continue to be healthy.

Junior League will break even with the spring season venue hire and club fees still to come in.

Performance pathway is holding a tournament for the first time in 3 years with 37 teams entering. The overall cost of the day will be approximately £2,100 offset by county entries fees making a loss of £650. However, this is covered by the profit made from the academies.

We have invested in coaches this year through the course reimbursement scheme. We have fully funded three level 2 and one level 1 coaches and have part funded a further five level 2 coaches and five level 1 coaches, awaiting completion.

The other costs incurred this year include, £277.50 for the website upkeep, £150.00 zoom subscription.

5.3 Officiating

SCNA OFFICIATING LEAD ANNUAL REPORT 2021-2022

It has been a great year for officiating within the County. It has been excellent to get back to some form of normal and continue with our strategies to increase the number of, and support our current, officials.

As highlighted last year, the pandemic enabled England Netball to move forward with significant changes to their officiating strategy, with a movement towards online courses with localised support mechanisms in place. I urge officials to check the Officiating pages of the England Netball website for further details.

A polite reminder that with new structures in place officials MUST now complete the INTO qualification before they can progress to C Award. This is a marked change to the umpiring system and may have a knock-on effect to local leagues and their officiating rules/regulations.

The COVID extensions supplied by England Netball will shortly come to an end so I urge all of those on their officiating journey to check their status. I have been in contact with all individuals who attended a course pre-pandemic to support them in obtaining their officiating qualifications. To confirm if course attendance expiry fell in the period <u>between 16th March 2020 and 1st September 2021</u> then officials were granted a 22-month extension to award deadlines. Those who fall outside of that window can still access extension if they feel this is appropriate.

A successful rules forum was provided for the Stoke-on-Trent League in Sept 2021. The event was attended by over 80 officials from within the County, and new rules books supplied to all those in attendance.

A return to assessments was granted in Sept 2021 and for the first time myself and active assessors created a schedule of assessment dates for the season. We offered dates for both the SCNA Junior League and local Stoke-on-Trent League to help reach the wide range of officials. This worked really well and is something we will continue to do in future years. I must say we have the best assessors in the country! Always willing to support and offer their expertise and assistance – a small but much valued group. With changes to the mentor/assessor criteria we have a list of individuals who would like to take on these roles within the County. As soon as England Netball release courses I hope to have individuals signed up and a secure future for our assessing team.

Congratulations to all officials who took their tests within Staffordshire this season, with successful passes for 4 INTO Award officials, 7 C Awards, and 1 B Award, plus 2 successful B Award Written Paper passes. We have another 8-10 candidates in the system for summer testing, so expect high numbers of qualified officials come the new season.

I look forward to continuing to work as COL, supported by the great team of assessors, mentors and officials that this County have.

5.4 Schools

Over the last 12 months I have been trying to reach out to more schools (with the help of Gemma)

The last County Schools tournaments saw a little higher participation and a couple of schools entering who hadn't entered before. Thomas Alleynes School in Uttoxeter qualified for the first time into the West Mids Tournament along with St Joseph's College, Newcastle under Lyme School and King Edward V1th School.

After the tournament a survey was sent out to as many schools as possible to find out their views on changing the U14 and U16 tournaments to weekdays instead of on a Saturday. Overwhelmingly the schools voted for a Wednesday or Thursday pm tournament.

I am now in the process of arranging a date for this to happen in November of this year, possibly at Denstone College. The U19 tournament will still be at Newcastle under Lyme School.

EN have been in touch recently to ask us if we would like to be a pilot County for the next County Schools tournaments. This entails us being able to use the EN branding to encourage more schools to enter, and for an EN partner or Roses player to attend our County Tournament. We would also get exposure on social media as a pilot County. I have said yes to all of the above!

Our aim must always be for more schools to enter the tournament.

Discussion

Bernie advised that the survey indicated that Thursday afternoon was the preferred choice for schools but for under 19s, it was Wednesday afternoon. The idea of having an England Netball partner at the tournament was welcomed by everyone.

The county rounds are usually in November but Bernie considered may be moving it forward owing to the often inclement weather.

Schools have indicated that they would like an under 12s tournament. Could be made into a tournament like it has done previously.

Denstone College may be able to offer courts. They have 6 courts available.

It was noted that a lot of primary schools do not have all the equipment they need to play netball, for example, one local primary doesn't even have netball posts.

Actions:

- 1- Hold county tournament the week before half term in October this year.
- 2- Explore use of Denstone College courts.
- 3- Future consideration to be given regarding the lack of equipment in primary school at committee meeting level.

5.5 Performance Pathway

Amy provided a verbal report:

There is good attendance with between 80-90 players. County tournament of 50 teams.

Attended Shropshire tournament and did some extra match play days also.

Julie and Vicky took a squad to Severn Stars, which was successful and they won.

2 apprentice volunteer coaches have been taken on. Leah – Level 2 coach and Nicola – working towards Level 2 who are doing really well. Julie, Vicky and Tracy are stepping down. Amy has replaced Julie. A few people have expressed an interest in helping, once Amy has settled in she will touch base with them. Dionne has joined the coaching team.

There are 10-15 players in franchise hubs. 6 went onto National Performance League squads, spread across Wasps, Stars and Loughborough.

Under 13 trials have been completed. Took 35 and all accepted places. Some girls had injuries so will be able to trial in September instead and long as they submit form before deadline.

Under 15 – haven't got an academy yet as there were so may (60) there need a further trial session. After this season EN procedure is that trials take place in September rather than June.

New EN rules have been implemented. There are only 20 places available on the under 15 pathway now. Previously there were 40. As a county we have committed to 2 development groups. Under 15 EN Player Development pathway – Maximum of 20. Under 14 and 13 is Staffordshire managed so we can choose how many are in them.

Athletes can chose which pathway they wish. Another change is that under 15 athletes must be on the County Pathway in order to trail for a EN Development pathway/school games squad. There are no longer open trials.

The franchises are not part the EN pathways. They have to attend a separate trial. Every franchise can only take 20 athletes under 17, 19 and 21. Trying to spread the talent rather than them all being under the same franchise.

There has been a better than usual response from under 15s.

No report. The post of Tournament Lead remains vacant and no tournaments have been held.
